INDEMNITY AGREEMENT

This Indemnity Agreement (the “Agreement”) made as of this _____ day of _____

BACKGROUND:

1. The International Gay Rodeo Association and its Officers will be protected against any personal Liability, claim, suit, action, loss, or damage that may result from the Indemnifier’s participation in The World Gay Finals Rodeo.
2. The indemnifier wishes to minimize and hardship the Indemnitee might suffer as the result of any Personal liability, claim, suit, action, loss, or damage that may result from the Indemnitee’s participation in the activity.

IN CONSIDERATION and as a condition of the Indemnifier and the Indemnitee entering into this Agreement and other valuable consideration, the receipt and sufficiency of which consideration is acknowledged, the Indemnifier and the Indemnitee agree as follows:

1. **Definitions**

The following definitions apply in the Agreement:

- a. “Activity” means the following:
The International Gay Rodeo Association (IGRA) will hold its annual World Gay Finals Rodeo, October 23-25, 2009 at the New Mexico State Fairgrounds in Albuquerque, New Mexico. The event will be held on property owned by the New Mexico State Fairgrounds and the city of Albuquerque, New Mexico. IGRA wishes to be indemnified against any and all liability that may result from this event.
- b. “Expenses” means all costs incurred in the defense of any claim or action brought against the Indemnitee including attorney’s fees.
- c. “Notice of Claim” means a notice that has been provided by the Indemnitee to the Indemnifier, describing a claim or action that has or is being brought against the Indemnitee by a Third Party.
