### **Executive Board Reports.**

The President, Vice President, and Secretary all deferred their reports to the convention floor.

Treasurer. David Hill presented the following Accounts Receivable:

- IAGRA owes \$600 plus \$200 late fee for annual dues, and
- SSRA owes \$600 plus \$200 late fee for annual dues plus \$217.32 for insurance.

Trustees Chairman. Ray Ostmann said that a short meeting would follow with an EPRB meeting to follow the Trustees meeting.

Administrative Assistant. Tommy Channel reminded everyone of the December 31<sup>st</sup> deadline to meet to be listed on the 2014 insurance policy.

Corporate Auditor. Jabby Lowe reported that he audited 10%, or 40, of 374 recent transactions.

### **Committee Reports.**

Hall of Fame. Roger Bergmann has compiled 3 documents regarding individual members, past committee chairs, and certified officials. The committee requested permission to include this information on the Web site (see attached report). The recommendation passed by a voice vote.

Gay Games 9. Judy Munson is composing a contact letter for all Trustees, committee chairs, and contestants. Discussion was on whether to use E-mail or a postal mailing. David Hill moved to E-mail to Trustees for further distribution to members and contestants and snail mail to contestants not in the IGRA system. The motion passed by a vote of 19-1.

### **Old Business.**

2014 Board Meetings. The summer meeting was to be held in Detroit as voted on in the last board meeting. Since MIGRA failed to submit a 2014 rodeo application, alternate cities were suggested, especially on a rodeo weekend prior to the Gay Games. Scotty moved to hold the summer meeting in Calgary. The motion failed by a hand vote 8-11. Tom Lott moved to hold the summer meeting in Denver. That motion passed by a voice vote.

### **New Business.**



## Hall of Fame Committee Report

During the Hall of Fame Committee report at last year's IGRA Convention I told the delegates multiple sources of information that they could access to find individuals worthy of nomination to the Hall of Fame. We still did not receive very many new nominations over the past year and I assume that part of the reason is the difficulty in researching the necessary information to enter on the Hall of Fame nomination form.

I have spent some time this year compiling the information from multiple sources into one document that lists individual accomplishments by their Member Association. A difficult task because of the way some individuals move their membership from Association to Association.

I have attached three documents. The first is the listing I just mentioned. The other two documents are: IGRA Committee Chairs and IGRA Certified Officials. These two lists have not been completed yet, because I am still trying to locate the data from 1995 to approximately 2000. I have not had time to add the names from these two lists into the listing by Member Association, but I do intend to get this done soon.

The Hall of Fame Committee is requesting permission from the Board to include this information on the IGRA Web site. We would like it to be a link that is accessed from the Hall of Fame site, so that members of all IGRA Member Associations can access the information to assist them in researching Hall of Fame nominations.

The list may be in its current format or it may be broken out into separate lists for each of the Member Associations. This will be determined while I work with Frank Harrell on this project.
