Guy began by stating a situation has come to the attention of GSGRA and NGRA in regards to rodeos, and that is the reason for the special trustees' meeting.

This past Thursday, the associations found out that the stock contractor is unable to provide 900 pound riding steers. Variances must be included on the rodeo application, or requested 90 days prior to the rodeo. The next trustees' meeting is not until April 24, and this would not be 90 days prior to the rodeos.

GSGRA requests a variance for Hot Rodeo in Palm Springs to use 800 pound steers instead of 900 pounds as specified in IGRA Rodeo Rules. NGRA requests the same variance for BigHorn Rodeo. Copies of "revised rodeo applications" are attached.

Chuck Browning moved to grant variances as stated above. Rob Somers seconded the motion, and the motion carried by voice vote.

Guy adjourned the meeting at 8:10 pm.
