There being no further business the meeting adjourned at 2:43 pm

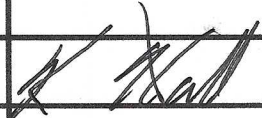
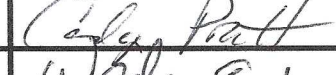
