Chuck Browning moved to approve the minutes from the November 13, 2025, and November 16, 2026 Board of Trustees Meetings. Motion was seconded by Steve Housley. Motion carried.

ITEMS OF BUSINESS

Ratify the Presidents appointment of the ROC Chair and the Area Lead positions. Chuck Browning moved to approve these appointments and was seconded. Motion carried.

Trustee Interpretation of Standing Rule XII Section 13 Item B. IGRA Secretary Gene Fraikes reported that this rule was found during the updating of the Standing Rules this year and it appeared to be wording left in error when the same subject matter was changed in a different location of the Standing Rules. A motion was made by Robert Thurtell but was withdrawn before getting a second.

It was determined that the Board of Trustees would instruct the Secretary to remove this item from the Standing Rules using the authority of the Resolution passed at the 2024 annual convention.

Venue change of CGRA Rodeo to Jefferson Co. Fairgrounds. Motion was made by Chuck Browning and seconded by Weston Crow-Tucker to approve the venue change and noted variances. Motion carried.

Robert Thurtell advised that CGRA was looking for people and organizations to man the kitchen at their rodeo should anyone be interested in a fund-raising opportunity.
